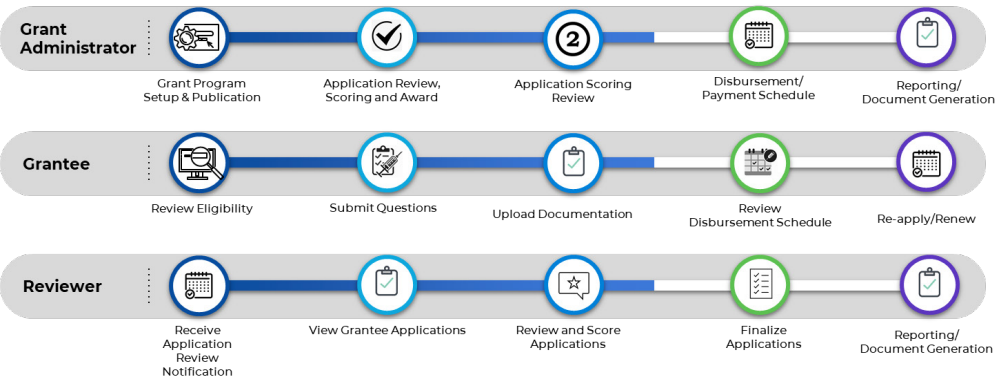

GEMS Resolution

GEMS addresses and resolves the following pain points for Grants Management from organizational perspective.



- Heavy Reliance on Manual Processes
- Redundant submission & review of information
- Inefficient process for tracking required documentation



- No risk-based audit/review process
- Data needed to report out to executive level not easily accessible
- Program Integrity response reactive rather than proactive



- Lack of clarity and frequent changes in requirements
- Continuous changes in procedures and policies and no centralized documentation of the changes



- Required forms change frequently, however, timely updates not always available
- Each agency has unique forms related to their programs.

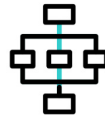
